

## ALLOTMENT AND ISSUANCE OF NEW SHARES PURSUANT TO THE VESTING OF SHARE AWARDS GRANTED ON 11 MAY 2017 UNDER THE TALKMED GROUP PERFORMANCE SHARE PLAN ("PSP")
